**A BILL**

To enact into law certain executive orders related to immigration and border security, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Secure the Southern  
5 Border Act.”

6 **SEC. 2. ENDING CATCH AND RELEASE.**

7 The provisions of the Presidential Memorandum, en-  
8 titled “Ending ‘Catch and Release’ at the Border of the  
9 United States and Directing Other Enhancements to Im-

1 migration Enforcement” (83 Fed. Reg. 16179, April 13,  
2 2018) are enacted into law.

3 **SEC. 3. BUILDING THE WALL AND OTHER BORDER SECU-**  
4 **RITY IMPROVEMENTS.**

5 The provisions of Executive Order 13767, entitled  
6 “Border Security and Immigration Enforcement Improve-  
7 ments” (82 Fed. Reg. 8793, January 30, 2017) are en-  
8 acted into law.

9 **SEC. 4. ENDING SANCTUARY CITIES AND ENFORCING IMMI-**  
10 **GRATION LAWS IN THE INTERIOR.**

11 The provisions of Executive Order 13768, entitled  
12 “Enhancing Public Safety in the Interior of the United  
13 States” (82 Fed. Reg. 8799, January 30, 2017) are en-  
14 acted into law.

15 **SEC. 5. REMAIN IN MEXICO POLICY.**

16 The provisions of the policy guidance entitled “Policy  
17 Guidance for Implementation of the Migrant Protection  
18 Protocols” (84 Fed. Reg. 6811, February 28, 2019) are  
19 enacted into law.

20 **SEC. 6. SUSPENSION AND LIMITATION ON ENTRY.**

21 The provisions of Proclamation 9880, entitled “Ad-  
22 dressing Mass Migration Through the Southern Border of  
23 the United States” (84 Fed. Reg. 21229, May 13,  
24 2019) are enacted into law.

1 **SEC. 7. ADDITIONAL MEASURES TO ENHANCE BORDER SE-**  
2 **CURITY.**

3 The provisions of the Presidential Memorandum, en-  
4 titled “Additional Measures to Enhance Border Security  
5 and Restore Integrity to Our Immigration System” (April  
6 29, 2019) are enacted into law.

7 **SEC. 8. SECURING THE SOUTHERN BORDER.**

8 The provisions of the Presidential Memorandum, en-  
9 titled “Securing the Southern Border of the United  
10 States” (April 4, 2018) are enacted into law.

11 **SEC. 9. EXPEDITED REMOVAL.**

12 The provisions of the Notice, entitled “Designating  
13 Aliens for Expedited Removal” (84 Fed. Reg. 35409, July  
14 23, 2019) are enacted into law.

15 **SEC. 10. PUBLICATION.**

16 In publishing this Act in slip form and in the United  
17 States Statutes at Large pursuant to section 112 of title  
18 1, United States Code, the Archivist of the United States  
19 shall include after the date of approval at the end an ap-  
20 pendix setting forth the text of the Executive Orders,  
21 Memorandums, Policy Guidance and Notices referred to  
22 in this Act (as in effect on January 19, 2021).
