**A BILL**

To require the Secretary of Transportation to conduct a study on the significant improvements and potential alternatives necessary to offset extended closures associated with Interstate Route 70, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “I-70 Detour Act”.

5 **SEC. 2. FINDINGS.**

6 Congress finds the following:

1           (1) Interstate Route 70 is the gateway to the  
2 Rocky Mountains and a major east–west interstate  
3 highway that runs through and connects 10 different  
4 states from Baltimore, Maryland to Cove Fort,  
5 Utah.

6           (2) Because of natural hazards, Interstate  
7 Route 70 through Glenwood experiences significant  
8 closures that last greater than 1 week, three or four  
9 times a decade.

10           (3) Substantial improvements to existing roads  
11 and possible alternative routes should be studied and  
12 then funded in a timely manner to ensure the con-  
13 tinuation of commerce as well as the safe movement  
14 of goods and people in the event that Interstate  
15 Route 70 is shut down again in the future.

16           (4) Closures of Interstate Route 70 are ex-  
17 tremely costly, with an economic impact estimated at  
18 \$1 million per hour.

19           (5) At this time, the local counties directly im-  
20 pacted by these closures and some of the alternatives  
21 proposed in this bill prefer for any county route or  
22 county road impacted by this bill to remain under  
23 county control and not become a state highway.

24 **SEC. 3. ALTERNATIVES.**

25           (a) REPORT.—

1           (1) IN GENERAL.—As soon as practicable, but  
2 not later than 2 years after the date of enactment  
3 of this Act, the Secretary of Transportation shall  
4 submit to Congress a report with recommendations  
5 for significant improvements and potential alter-  
6 natives necessary to offset extended closures associ-  
7 ated with Interstate Route 70, including—

8           (A) at least 1 alternative that includes the  
9 possibility of improving Catherine’s Store Road,  
10 as proposed by Garfield County, Colorado;

11           (B) at least 1 alternative that includes the  
12 possibility of improving the 6 spot locations to  
13 existing roads, as proposed by Eagle County,  
14 Colorado;

15           (C) at least 1 alternative that includes the  
16 possibility of improving an existing road down  
17 Cottonwood Creek, as proposed by Eagle Coun-  
18 ty stakeholders and the Colorado Department  
19 of Transportation;

20           (D) at least 1 alternative that includes the  
21 possibility of improving Interstate Route 70  
22 system resilience and reducing risks from near-  
23 by hazards; and

24           (E) any other significant improvements  
25 and alternatives proposed by Garfield County,

1 Colorado, Eagle County, Colorado, the Colorado  
2 Department of Transportation, or the Secretary  
3 before the date of enactment of this Act.

4 (2) CONTENTS.—The report required under  
5 paragraph (1) shall include information regarding  
6 the cost and feasibility of each alternative or im-  
7 provement described in such report.

8 (b) LEGISLATION.—

9 (1) IN GENERAL.—Not later than 60 days after  
10 the Secretary submits the report to Congress under  
11 subsection (a), the Committee on Transportation  
12 and Infrastructure of the House of Representatives  
13 and the Committee on Commerce, Science, and  
14 Transportation of the Senate shall produce legisla-  
15 tion based on the recommendations provided by the  
16 Secretary in such report.

17 (2) AUTHORIZATION OF APPROPRIATIONS.—  
18 The legislation produced under paragraph (1) shall  
19 include a provision to authorize appropriations to  
20 carry out any activities authorized in such legisla-  
21 tion.

22 (3) CONSIDERATION.—Not later than 60 days  
23 after producing legislation under paragraph (1), the  
24 committees referred to in such paragraph shall move  
25 to consider such legislation.
